

# **October 2023 Minutes**

1 – All approve the meeting minutes from last meeting

## 2 - Rep Report:

U9: Teams games will begin shortly. Still no jerseys, some concerns raised by a parent with coach related to a players ice time. Coach and Manager ask to monitor and report back if parent is not following 24 rule.

U10 and 11; Good communication, little to few complaints. Jen to follow up with NOHA about U11A goalies. Teams competitive to date.

U13; Good communication, Teams competitive to date.

U14 and 15; Good communication, Teams competitive to date. Some suspension issues at the U14. Coaches reminded about the Maltreatment Rules and asked to review.

## 3 – House Report:

U18, draft occurred October 22, 2023. Some parents are not overly pleased with selection. Selection has been done in a fair and equitable manner to ensure all teams are competitive.

One U15 team has voted to purchase a set jersey.

## 4 – Budget Report:

Registrations are at about 635+ players today which is inline with previous years.

## 7 – Analytics

Andrew made a presentation of the value of Association owned cameras that a subscription for analytics. The most applicable camera and software is provided from by Spideeo. Two cameras would cost approximately \$3500.00 and the yearly subscription for data storage, analytics and live streaming is about \$8500.00

The group debated the positives and negatives of this and agreed that if live streaming could be made available to all teams including HL and that we could add advertisement it would be sound investment and would help grow hockey and provide an enhanced coaching tool for NBMH coaches.

Darrell identified that we shouldn't use registrations to pay for this as not all teams would benefit. However, suggested that if we had sponsorship that would be possibly a better avenue to fund the initiative.

Action: Andrew and Rob to review sponsorship revenue and assess if we there is sufficient funding to support this over a three-year period

#### 9 - Challenge Cup
